## PLEASE READ AND SIGN OUR TERMS AND CONDITIONS

- 1. Trevarrian Holiday Park do their upmost to provide security for caravans stored with them, however it is impossible to completely eliminate the risk of theft or damage. Since we do not accept liability for the loss or damage of a caravan, other than loss or damage caused by our negligence, we suggest that all caravans stored with us have appropriate insurance policies for the durations of the agreed storage.
- 2. For health and safety reasons there is a limit of 6 people using the seasonal pitch at one time.
- 3. Pitches include parking for 1 car. Additional cars must be parked in the parking areas designated by management.
- 4. The Caravan Owner is responsible for properly securing the caravan and to immobilise the caravan against theft, as per the conditions of their insurance policy.
- 5. All awnings and ouside storage boxes are left at the owners risk.
- 6. The caravan must remain roadworthy and in acceptable condition at all times. We advise caravans to be cleaned and serviced regularly.
- 7. Trevarrian Holiday Park excludes all liability caused by vermin infestation. A vermin regime is in place and monitored regularly. Caravan owners are advised not to leave any food sources in the caravan when not in use.
- 8. No explosive or inflammable substances may remain in the caravan whilst unoccupied, with the exception of gas cylinders, suitable for use within the caravan, which may be left switched off and disconnected inside the caravan.
- 9. Electric hook ups are to be disconnected when the caravan is not in use
- 10. The seasonal pitch must be left clean and tidy at all times with no items left under the caravan at any time.
- 11. No alterations can be made to your seasonal pitch without prior consent from the park owners.
- 12. Caravan owners must report to reception on arrival and inform us of how long you intend to stay.

13. Caravan owners must telephone and let park owners know if anyone else will be using your caravan and when they will be doing so.
